In the survey, which was THE ISRAEL conducted on the internet and by telephone (supplements of groups that are not sufficiently represented on the network) between November 25-28, 600 men and women were interviewed I N S T I T U T E in Hebrew and 150 in Arabic, constituting a representative national sample of the entire adult population of Israel aged 18 and older.
